Because we need to protect the old documents of the cemetery, we need to go from a medium to a large lock box. A motion was made by Judy Hazlett Ritter and seconded by Judy Walz to rent the large box. The motion was carried. It will cost \$30, \$10 more than the medium size box.

A motion was made to add Sandy Hopkins to be Assistant Treasurer so that she is able to help with the banking and business of the cemetery. Pat Spencer Marrero made a motion to add Sandy and it was seconded by Janet Spencer Barr. The motion was carried.

An Oak tree has died along the edge of the cemetery near the road. Mike Spencer had questions about replacing the tree with a new tree in memory of his father. Dan offered to help remove the dead tree and help to plant the new tree if that will work for Mike. They will check the best way to replace the tree but would not do it until fall.

The trees on the drive are now meeting over the drive. It was discussed as to whether they need trimmed as some vehicles may be tall enough to touch the leaves. It was decided to not do anything about that at this time.

Stephanie gave Harold's report on the grounds. There are major holes in the deep part of the new section of the cemetery. It is hard to mow over them. Todd said he will look at it and decide what needs to be done.
